AMENDMENT TO DECLARATION OF
COVENANTS, CONDITIONS AND
RESTRICTIONS FOR COPPER RIDGE

THIS AMENDMENT to the Declaration of Covenants, Conditions and Restrictions for Copper Ridge, made this 26th day of January, 2010 by the lot owners and members of Copper Ridge Homeowners Association, Inc. (hereinafter, "the Association"),

WITNESSETH:

THAT WHEREAS, a Declaration of Covenants, Conditions and Restrictions for Copper Ridge is recorded in Book 11544, Page 8887 of the Wake County Registry ("Declaration"); and

WHEREAS, Article XII, Section 12.1 of the Declaration provides that such Declaration may be amended by the affirmative vote of sixty seven percent (67%) or more of the Members entitled to vote at a meeting called for the purpose of considering such amendment;

WHEREAS, the Association held a meeting to vote on this amendment which alters Article V, Section 5.10 of the Declaration and sixty seven percent (67%) or more of the Members entitled to vote at such meeting voted in favor of such amendment; and

NOW THEREFORE, the undersigned does hereby declare that the Declaration of Covenants, Conditions and Restrictions for Copper Ridge shall be amended as follows:

1. To amend Article V, Section 5.10 of the Declaration by deleting that section in its entirety and inserting in lieu thereof the following:

“Section 5.10. “No fence or wall shall be erected, maintained or permitted upon the Property, other than those installed by Declarant prior to the initial conveyance of each Lot.”

2. This amendment shall be effective upon recordation in the Office of the Wake County Registry.

3. Except as amended hereinabove, the remaining portions of the Declaration as originally recorded are hereby restated and re-acknowledged.

WHEREFORE, the President and Secretary of the Association have hereunto affixed the corporate certification for the purpose of enacting the foregoing amendment.

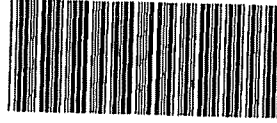
